THIS NOTICE IS REQUIRED BY LAW (OHIO REVISED CODE SECTION 5719.04 AND 5719.08)

Per the Ohio Revised Code Sections 5719.04 and 5719.08, the 2017 and prior General Business Personal Property Tax List, as returned delinquent by the county treasurer of Franklin County, are contained and described in the following list.

When taxes stand charged against a person are not paid within the time prescribed by law for their payment, the county treasurer, in addition to any other remedy provided by law for the collection of taxes, shall enforce the collection of the taxes by a civil action in the name of the treasurer against the person for the recovery of the unpaid taxes. (Ohio Revised Code 5719.08).
