Racism: *Where Do We Go From Here?* How Media Perpetuates Bias

One form of media bias or perceived bias occurs when journalists, news producers, and mass media outlets select events to cover and how they are reported. It's a very subjective judgment about if and when bias occurs, but countless studies reveal examples, such as the word "black" being used as many as three times more frequently in news stories than the word "white," which can condition viewers to associate Black people with



Strickland negative news and crime.

In the 1960s, the media were accused of having a role in the racial violence, by failing to recruit more Black journalists or to adequately report the conditions of the ghettos.

Another example of media bias was demonstrated during the rise of the film industry, when studios were owned by white people who chose how to portray Black people in their big screen

productions. In movies, as well as news reports, Black men are often criminalized and presented as violent. As late as 1977, a study by the U.S. Commission on Civil Rights reported that stereotyping of Black people was still prevalent on television.

The stereotyping continued according to a 1997 study that examined racial and gender bias in advertising and revealed that Black women in fashion magazines wore the majority of animal prints depicting predatory animals.

Is there media bias occurring even when covering Black athletes?

At CMC on July 8, panelists examine today's media bias, intentional or inadvertent, how it is perpetuated and by whom. How will the current climate and the Black Lives Matter movement impact media bias and stereotyping? Where do we go from here?
