Achieving Racial Equity in Your Non-Profit

As the nation struggles with systematic racism and inequity, nonprofits working to fulfill their charitable mission and their community roles also wrestle with their own internal inequity. Recent studies emphasize the need for nonprofits to close the racial leadership gap. Only 20% of social services organizations and the foundations that support them have people of color at the helm and also lack an equitable workforce, or a workforce that reflect the clients they serve and the community in which they work. But having a diverse workforce still has not led to

a move diverse leadership group.

Achieving racial equity is an imperative for the central Ohio nonprofit sector that serves the community's most vulnerable residents who are disproportionately Black and Brown. This forum will feature new survey findings that will reveal the status of racial equity for local nonprofits. This data is currently being collected and analyzed by the United Way of Central Ohio and Human Service Chamber and presented for the first time at CMC.

According to United Way of Central Ohio's President and

CEO Lisa Courtice, this analysis will be the first one on racial equity for central Ohio and will inform the creation of a road map for achieving racial equity. Dr. Courtice said "the nonprofit sector has a lot to learn about how to achieve racial equity internally and externally. We must commit to a diligent journey that includes continuous learning, policy improvements and a creating inclusive cultures. We are eager to learn from nonprofit leaders who participate in this survey."

Michael Wilkos, Senior VP of Community Impact, United Way of Central Ohio, will present an overview of survey results. 
